LAUNCHING THE FAIRFORWARD PROJECT

The journey towards inclusive workplaces officially began with the Online Steering Committee Meeting held on February 19, 2025. This kickoff event brought together 13 representatives from partner organizations across Europe, setting the foundation for project activities and collaboration. Participants discussed the key objectives of FairForward and reinforced their commitment to creating fairer labor markets for all.





WHY FAIRFORWARD?

The transition to a digital and green economy, along with post-pandemic recovery, has highlighted the need for inclusive workplaces. Migrants, LGBTQIA+ individuals, persons with disabilities, and those with mental health challenges often face barriers that limit their potential. FairForward tackles these challenges by empowering workers, fostering inclusive policies, and promoting social dialogue.

- Raise awareness of DEI principles among workers and employers.
- Develop practical tools to implement inclusive practices.
- ✓ Train worker representatives in advocacy and negotiation.

Manual on Inclusive Policies: A go-to resource for implementing and negotiating inclusive workplace strategies.

Capstone Wrap-up Conference: A high-impact event showcasing achievements and shaping the future of inclusive labor markets.
