### **Section II Description and scope of services. Obligations of service provider.**

The subject of this procedure is the provision of simultaneous interpretation and technical services for an event organised within the above-mentioned project.

The event will take place online on 15 December 2025 in the framework of the FairForward project.

The service shall include:

#### **Lot 1 – Interpretation Services**

- Simultaneous interpretation from English into:
  - Polish (PL)
  - Serbian (RS)
  - Spanish (ES)
- Provision of 6 professional interpreters for the duration of the event;
- Interpretation coordination services.

#### **Lot 2 – Interpretation Booths and Equipment**

- Provision of 3 interpretation booths fully equipped with all necessary interpretation equipment;
- Provision of receivers, microphones and related interpretation infrastructure;
- Installation, testing and dismantling of equipment.

#### **Lot 3 – Technical Event Support**

- Technical assistance throughout the event;
- Operation of the conference platform;
- Participant registration management;
- Video recording of the event.



The service provider shall ensure high-quality interpretation services, professional technical support, uninterrupted operation of all equipment and effective coordination of all event-related services.

The provider shall be responsible for all equipment, staffing, technical infrastructure and operational arrangements necessary for the successful delivery of the services.

Service providers may submit offers for:

- Lot 1 only;
- Lot 2 only;
- Lot 3 only;
- Any combination of the above lots;
- All lots combined.

Partial offers are therefore permitted.

The Contracting Authority reserves the right to award separate contracts for individual lots or a single contract covering all services, depending on the quality of the offers received and the best value for money principle.

### **Section III Term of services**

The service provider is expected to respect the following deadlines:

- The offer shall not require a prepayment
- The invoice for the services shall be issued within 14 days from completion of the service.
- The time limit for payment of the invoice must not be shorter than 30 days

After signing the contract any major changes to the contract shall be excluded. A draft contract may be delivered via e-mail on request.
